Always a highlight for children, teachers and parents alike, this year's event raised a wonderful £786.85.

Christmas Disco P&L

A very well attended event, with the new style ticketing via Arbor proving to be successful. We need to ensure the cut-off time as well as date is well publicised when using this platform again, as there were quite a few parents who did not realise that the ticket sales stopped at 5pm on the closing date. These children were still able to attend with Mrs Page invoicing them individually for their child's ticket.

After costs, the disco raised a fantastic £963.04. This was less than the May disco, however we expected children might have other Christmas events outside of school, so were pleased with this amount.

Current Balance

£22,996.05 in bank, plus petty cash in treasurer's possession.

Summary of the Year

The financial year ran 01/08/22-31/07/23. This is the period accounting for charitable organisations is based on.

The income for the above period was £14,303.79, with expenditure of £16,888.10. This includes the £11,000 donation to the school for additional learning activities, the panto, equipment and the sensory garden (versus \pounds 7,000 the previous year).

This meant a nett deficit of -£2,584.31 due to a higher donation than the previous year and a lower amount raised at the fireworks due to the postponements and the poor weather on the actual night. The success of the 2023 fireworks and other fundraising events means that the current financial year has started well and we can be confident in ending the year without a deficit even with a like-for-like donation to the school.
